PAYMENT PLAN SCHEDULE

Pay \$600 non-refundable Deposit upon registration \$1000 down payment due at the start date of class

First payment due on November 7th and on the 7th of each month following for 10 months =\$894.61

Refund policy

When a student withdraws from the program, monies paid will be refunded as follows:

| 1. | After the first day of program to 10% of the program | 10% Tuition Charged |

| 2. | 10.1% to 24.9% of the program: | 25% Tuition Charged |
| 3. | 25 % to 50% of the program: | 50% Tuition Charged |
| 4. | Over 50% of the program: | Full Tuition Charged |

Right to cancel enrollment agreement (school and student)

The student or school has the right to cancel the enrollment agreement any time up to the first day of class. If the student cancels, all money will be refunded before 2 weeks prior to the start of class. After two weeks before the start of class, the \$600 deposit will not be refunded. However, if the school cancels the enrollment

agreement, all money will be refunded prior to the first day of class. After the first day of class, in either case, the refund policy above will be in effect.

Right of withdrawal or termination of enrollment (school and student)

Withdrawal or termination prior to start of program;

This will be treated as in "Canceling enrollment agreement" above.

Withdrawal, abandonment or termination after program starts

The school will only terminate the student in the case of misconduct, non-participation, or failure to pay tuition or fees. The student may terminate the program at any time, and for any reason. The above refund policy will apply for every case.

Program start date

Credits, hours and financial, for prior training

Credit, hours, and discounts for prior training will be given on a case by case basis. Hours accepted from another school in similar areas of study will be charged at \$5 per clock hour.

Total hours of program, including prior training credit

650 hours

Attendance requirements

Attendance is very important as almost everything learned is hands on and participatory. A student may miss up to 3 days without having to complete make-up work, as long as 12 hours prior notice is given before each day missed. If 4-6 days are missed, the student must make-up in one of three ways: 1-completing homework assigned by the appropriate teacher. 2-private tutoring with the teacher. Or 3-self study and demonstration massage on a teacher, at the teacher's tutoring rate. If more than 6 days are missed, a meeting will be held between director and student to evaluate the student's continued interest and to decide if withdrawal is necessary. If more than 6 days are missed without asking for a Leave of Absence, the student will be withdrawn.
